

## Feng Chia University Recipients of International Student Financial Aids for Fall 2019 (Fourth Period Application)

1. The recipients of International Student Financial Aids for Fall 2019 are 27 as follows.
2. FCU offers two kinds of Financial Aids. NT\$ 120,000 for one academic year and NT\$60,000 for one academic semester. The financial aids will be given in two semesters. The award is transferred semiannually to recipients' accounts start from November 2019 and April 2020.
3. In accordance with the Feng Chia University Implementation Guidelines for Feng Chia University Guidelines for Strengthening Educational and Labor Rights for Student Part-time Assistants, the college will offer relevant research or service opportunities to students who receive financial aids. Each college will use their own procedures to enforce the financial aid rules.
4. Students who receive FCU International Student Financial Aid must reply to study intention online before **July 31, 2019**, the link will be informed in the letter of acceptance. **The offer of financial aid shall be revoked if the student does not reply to study intention before the deadline.**
5. Students must have **completed tuition payment**, registration and course selection procedures for the semester for which the financial aids is awarded.
